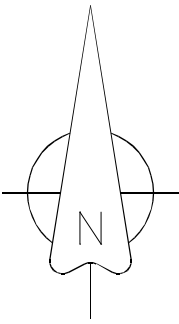


TREE SURVEY

Refer to the Tree Survey Report carried out by Green Tree Arboricultural Consultants dated April 2025.

Trees and their categorization shown on this drawing is based on the independent Tree Survey Report carried out by Green Tree Arboricultural Consultants.

All trees shall be assessed annually or following periods of high winds or storms.

Positions of trees shown taken from topographical Survey or shown in approximate locations where trees were not picked up by the Topographical Surveyor.

Locations of additional tree nos. 436-463 plotted by Green Tree Arboricultural Consultants and in some instances shown in their approximate locations.

The group of riverbank trees, reference G01 shown at the southern end of the site has been surveyed remotely by Green Tree Consultancy on 28/04/25.

All trees proposed for retention during any proposed development for the site shall be protected in accordance with BS 5837:2012 guidelines and monitored and assessed during the construction phases and on completion of the development.
